Minor passport renewal - If one of the parents is holding a foreign passport, he/she has to produce a letter along with the minor application stating they have not submitted any application for foreign citizenship for their child. Minor Applicant cannot change their permanent address based on their Adhar card or any other proof under their name.

10. Registration of Birth of Indian Children Born In Uganda/Rwanda/Burundi: Birth of an Indian child outside India needs to be registered with the High Commission within one year. Passport / Visa Services : Consular Services

Eyes should be open and clearly visible (No hair across the eyes) Skin tone should be natural. It should not be too dark or too light. Head coverings, hair or facial ornaments should not obscure the face. The photograph must be taken in a colored attire, for example, a medium blue shirt etc.

Your Indian passport renewal will take 3-6 weeks if the last passport was issued in India. You can get a new passport in 10 days if your last passport was issued by the Indian Embassy in the USA. You can apply for renewal 1 year or 365 days before expiry.

Renew Indian Passport in USA (CKGS Process, Documents)

(i) Applicants are required to do one time registration at <https://embassy.passportindia.gov.in/> (Passport Seva at Indian Embassies and Consulates) and create a USER ID. (ii) Login using the newly created USER ID and fill in the application form online at the same portal. (iii) After submitting the form online, take a print out of the application.

Indian Passport Renewal or Fresh Passport An Indian passport is normally valid for 10 years from the date of issue. Expiration date is denoted by the term 'Final' or 'F' after the expiration date. e.g., 12.05.2009 (Final) or 12.05.2009 (F). You can not renew the passport more than one year before the expiration date of your current passport.
