To qualify for a fee waiver, you must demonstrate to the U.S. government that you can't afford the filing fee due to one or more of the following reasons: Your total annual household income is at or below 150% of the Federal Poverty Guidelines. (See the "150% of Poverty Guidelines" column in the tables above.

### **USCIS Fee Waivers and Reductions - Boundless**

Non-Federal organizations that use the poverty guidelines under their own authority in non-federally-funded activities can choose to use a percentage multiple of the guidelines such as 125 percent or 185 percent. The poverty guidelines do not make a distinction between farm and non-farm families, or between aged and non-aged units.
